This admission agreement covers Boarding, Dog Day Camp and Grooming- It is NOT a commitment to use our services. This contract covers today's visit, as well as all future visits.

We have provided our Doghouse at Lake Oconee admission agreement so that you may further understand what is required of you and your dog before enrolling in any of our services.

You will be asked to print, read, sign and bring at drop off your pet, or read and sign this agreement at the time of your dog's acceptance into our facilities.

This is an agreement between Doghouse at Lake Oconee (Doghouse at Lake Oconee, LLC) and

I, (Print Owner Name) _____ (owner), hereby certify that my dog(s) Pet Names:

_____ is/are in good health and have not been ill with any communicable condition in the last 30 days or any boarding or day camp registration. I further certify that my dog(s) have not shown any aggressive or threatening behavior towards any person or any other dog. Doghouse at Lake Oconee agrees to exercise due and reasonable care in the handling of dogs, and in keeping the facility properly enclosed and sanitary. All dogs are cared for by Doghouse at Lake Oconee without liability on Doghouse at Lake Oconee's behalf for loss or damage from disease, theft, fire, escape, injury, or harm to persons, other dogs, or property by said dog(s), or for other unavoidable causes.

I HAVE READ AND UNDERSTAND THE FOLLOWING:

- 1. I understand that I am solely responsible for any harm caused by my dog(s) while my dog(s) is/are in the care of Doghouse at Lake Oconee and release Doghouse at Lake Oconee of any liability arising from my dog's attendance and participation at the day camp, boarding or grooming.**
- 2. I recognize that there are inherent risks of illness or injury when animals are allowed to be in close contact with one another. Such risks include, but are limited to, problems resulting from rough play, canine cough (doggie colds) and dog bites.**
- 3. I further understand and agree that in admitting my dog(s) to Doghouse at Lake Oconee, the staff have relied on my representation that my dog(s) is/are in good health and have not harmed or shown aggressive or threatening behavior towards any person or any other dog.**
- 4. I understand that my dog(s) will be playing in open areas with other dog(s) and accept that when dogs play in groups, they may get dirty and nicks and scratches may occur, as well as any other inherent risks that are involved and I hereby release Doghouse at Lake Oconee of any liability: I further understand and agree that Doghouse at Lake Oconee staff will not be liable for any or all problems which may develop.**
- 5. I further understand and agree that any problems which develop with my dog(s) will be treated as deemed by Doghouse at Lake Oconee staff, at their sole discretion, and that I assume full financial responsibility for any, and all expenses involved if I or Doghouse at Lake Oconee decides to obtain medical treatment. I also understand Doghouse at Lake Oconee DOES NOT have a veterinarian on staff, and if it is deemed that veterinary care is required, and you are unable to be reached, the vet cost may be added to your bill if you cannot be reached by designated veterinary office for payment.**
- 6. I accept that if my dog causes any excessive damage to the facility that I could be asked to pay for repairs.**
- 7. I understand that if my dog is not spayed or neutered, they will not be allowed to participate in play with other dogs. Private play is an option for unaltered dogs.**
- 8. I further understand that if my dog shows any signs of aggression towards other dogs, that their acceptance into day camp play will be reevaluated and possibly revoked until such time as an approved trainer has worked**

with the dog and corrected the issue. They will be given between 1 and 3 chances depending on the situation surrounding the aggression before they are forbidden to participate with other dogs.

9. Human aggressive dogs, or dogs with fear/aggression issues, will not be allowed to stay at Doghouse at Lake Oconee.
10. As stated above your dog will be interacting in an open play area with other dogs. I understand that doing so could end up with my dog getting some nicks and scratches from play with other dogs. I need to understand that if I do not want my dog to attend day camp that I need to notify the staff at the time of drop off.
11. As a responsible pet owner, I promise to keep my pet(s) up to date on all vaccines, including Bordetella, Distemper, and Rabies, and all other state required vaccines. It is required by Doghouse at Lake Oconee that you provide official updated records from a veterinarian before you are allowed to board, groom or attend day camp.
12. Doghouse at Lake Oconee is not responsible for informing of due dates on vaccines now will Doghouse at Lake Oconee provide vaccine records for any reason. Furthermore, when pet(s) vaccines are updated, a copy must be provided to Doghouse at Lake Oconee for our records to stay updated, otherwise we will assume that your pet(s) are not current on vaccines.

Fees:

Days and Hours: Monday through Friday 7:30am- 6pm, Saturday 8am – 12am, after noon on Saturday and all day Sunday by request. If your pet is participating in day camp and not picked up by 6 pm your dog may be placed in boarding for the night at current rates.

Emergency:

In the event of an emergency Doghouse at Lake Oconee will first attempt to contact the owner, followed by an attempt to contact the emergency contact provided. Doghouse at Lake Oconee may also contact the veterinarian listed, or any emergency veterinarian of Doghouse at Lake Oconee's choice, if the circumstances are deemed such that immediate treatment is necessary. Doghouse at Lake Oconee staff retains sole discretion in emergency matters without liability, and the owner of the dog agrees to promptly pay for all

medical treatments received. Owner agrees to pay for reasonable attorney's fees incurred by this boarding facility in the collection of any boarding grooming or daycare, or other charges incurred by the owner of the above animal.

This contract is binding for the current boarding, day camp and grooming date and any future dates. Prices and fees are subject to change without notice.

I certify that I have read and understand the policies of Doghouse at Lake Oconee as set forth on the preceding pages. I have read and understand the conditions and statement of this agreement.

I acknowledge and accept that all the above policies refer to day care, overnight stays, and grooming and this release serves at accepting these conditions for all 3 services.
